

ALSA BUCKEYE REGIONAL CHAMPIONSHIP

October 9-10, 2010

DIRECTIONS...Eden Park Equestrian Complex is located on Blayney Road off of SR 61. Take the SUNBURY Exit off of I - 71. Follow SR 36 East towards Mount Vernon. Take SR 61 north to Blayney Road. Turn left onto Blayney Road. The Eden Park Complex is on the left.

HEALTH REQUIREMENTS...Lamas coming from within Ohio must be free of disease. Out-of-state lamas are required to have only a vet certification of good health issued within 30 days of the show date and show no signs of disease. Vet's ID# must be on the certificate. Bring certificates with you to registration.

ARRIVAL & REGISTRATION... The Show Crew will be available to direct exhibitors to their pre-assigned stalls on Friday, October 8th from 3:00 p.m. until 7:00 p.m. and Saturday, October 9th from 7-8 a.m. Stop by the main entrance of the Coliseum for registration and stall assignments. **After the show begins, packets can be picked up at the clerk's table.**

SECURITY...Will be provided Friday and Saturday nights by llama breeders.

STALLS...are pre-assigned. **The use of straw bedding is prohibited** (facility contract). You may use carpeting, stall mats, paper bedding or wood pelleted material. Stall floors are packed dirt. **All lamas must have stall assignments. Only two (2) lamas are permitted per stall – no exceptions!**

TACK STALLS...Common tack areas will be available. You may also store tack in front of your stall(s).

ELECTRIC AND WATER...are available nearby at no charge.

GROOMING...Wash areas are provided. Blowing should be done outside.

DUNG PILES...Designated areas will be made available specifically for usage as "dung piles". Please comply by using only these designated areas.

PARKING...After unloading, all vehicles and trailers will be parked in a large, open area near the barn. No parking fee. You may drop your trailer.

RULES AND GUIDELINES...All rules and guidelines for this show will be in accordance with the ALSA Handbook.

PHOTOGRAPHER...A Show Photographer will be available all day to take your and any of your lamas' pictures should you desire. Please have all Grand and Reserve Champions lamas' pictures for *SHOWRING*.

CLASS LIST...A list of classes can be found on the ALSA website under the regional link. Take care in choosing the correct class number for which you have qualified and are entering. **Showmanship, performance, and youth judging classes will be held on Saturday.** All remaining halter classes will be on Sunday. **A FINAL SHOW SCHEDULE will be sent to you after entry is made.**

ENTRY FORM...Please fill this form out correctly and completely. **The first line of the entry is for animals entering halter classes and performance. Youth entries are separate.** Lamas entered in the wrong classes may not be shown in that class or changed to another class after the deadline. Forms incomplete or incorrect will be returned to entrant. Please call if you have questions.

REGISTRATION PAPERS...All llamas and alpacas (except non-breeders and lamas entered in youth classes) must be registered with the ILR or ARI. See the ALSA Handbook for exact rules. Copies of registration certificates must be sent with your entry.

ALSA MEMBERSHIP...All exhibitors at the ALSA BUCKEYE REGIONAL CHAMPIONSHIP must be members of ALSA. **Please send a copy of your membership card and youth membership(s) with your entry. Also, please send your youth's date of birth and address, if different from the farm entering.**

DEADLINE...Send your entry form, copy of ALSA membership card(s), accompanying registration certificates, permission-to-show forms, and fees to Mike Haumschild, **postmarked by Monday, September 24th.** If necessary, fax this information to 740.824.3579. Remember to include a permission-to-show form if your name is not on the registration papers.

JUDGE...The judge for the show is **Allen Davis from New Castle, IN**

FOOD AND BEVERAGES...There is a restaurant on site. **No outside food or drink is allowed in the restaurant or office areas while the restaurant is open.**

SMOKING...is prohibited in all stabling areas. Smoking is permitted in the

restaurant and lounge areas of the Coliseum ONLY.

EXHIBITOR MEETING...There will be an exhibitor meeting for everyone on Saturday, October 9th in the stands outside the arena. Another meeting will be held on Sunday, October 10th as well.

FARM DISPLAY...You may put a farm display in front of your stall(s). Aisle ways are spacious enough for chairs and small tables.

SPONSORSHIPS...are welcomed and encouraged! Gold sponsors of \$300 and up, and silver sponsors of \$100-\$299 will have premier stalling and recognition in the program. Bronze sponsors (up to \$100) will receive recognition in the program. Please consider sponsoring. Call Mike Haumschild (740.824.3120) for details.

CAMPING...Area is near the barns. Electricity and water are available. There is a \$30 fee for camping. **Please include camping fee on your entry.**

VENDORS...Are most welcome and will be housed ring-side in the Coliseum. There is a \$30 fee for vendor set-up. Please confirm with Mike Haumschild.

DEPARTURE...Exhibitors are permitted to leave as soon as they are finished showing.

WEATHER...Can be warm and delightfully sunny or cool and rainy. The facility is entirely under one roof and climate controlled. Bring fans for your lamas (just in case).
