This spring they will be held at the home of Randy and Leigh Snyder on Saturday, May 15. These are 2 separate Level I ALSA Shows.....the Cardinal Show, to be judged by Deb Yeagle, and the Lincoln Show, to be judged by Cathie Kindler.

Since payment must be sent with all entries, faxed entry forms cannot be accepted.

Pens can be provided at no extra charge if asked for prior to arrival. Ample shade is provided on the farm. Bring lawn chairs, too.

You are welcome to come in Friday night. If you have a camper/motorhome, we can provide electrical and water hook up. We can also provide indoor accommodations with advance notice either at our place or my daughter's place. The closest motels would be Tuscola (to the west), Paris, Mattoon, Charleston (to the south), Danville, Champaign, Urbana (to the north) and as to the east...probably Rockville, Indiana (about 30 miles). There is also a bed and breakfast in Chrisman, Illinois, which is about 10 miles east of the farm. Contact Leigh for more info.

Please be considerate and get entries to Leigh ASAP. No late fees will be charged, and last minute entries will not be refused upon arrival. But try to get info and fees in by Wednesday, May 12th.

There is an additional \$30 fee for exhibitors who are not members of ALSA. This is **PER FARM**, not per entry. Also, the non-member youth ALSA fee of \$15 is required.

Food and drinks will be available.

Exhibitors Meeting: For your convenience, there will be an exhibitors meeting Saturday morning prior to starting the show for the purpose of updating information pertaining to the show. ***It is very important that you attend this meeting to ensure that you know what is happening!***

Trophies: Rosettes will be awarded to the Champion and Reserve Champion in each wool, non-breeder, get of sire, and produce of dam division.

All required entry fees, copies of ILR registration certificates, and copies of ALSA membership cards must accompany the entry form. Exhibitors are not required to be members of ALSA to participate, but, as noted previously, non-ALSA members must pay a \$30 per farm fee per show. Entries for non-breeders must have that indicated on their registration papers or have an accompanying veterinarian certificate.

Health Papers: Since this is on private property, the health papers on out of state animals will not be enforced. However, you decide if it's worth the risk of being stopped enroute and asked to show them by a state trooper. Good judgment should be used as to whether an animal has a health issue and risk being transported and exposed to or coming in contact with other animals. **Contact Leigh Snyder concerning health paper requirements.**

All rules and guidelines for this show will be in accordance with the most current ALSA Handbook. The most current ALSA handbook will be available for viewing and rule verification at the check-in table.

The only class changes that will be permitted after an exhibitor's arrival at the show will be if there are an insufficient number of entries in a division to hold points. Then classes may be combined if exhibitors are in agreement with such change. Once llamas are at the show, only a judge may move an animal to a different wool division. It is the responsibility of the exhibitor to enter his/her animal(s) in the proper class(es). No substitutes will be allowed from the original entry form unless an animal becomes ill and permission is granted by the Show Superintendent or Clerk ***prior*** to the show. Any substitute animal will show in the classes entered for the original animal.

Entry fees will NOT be refunded if an animal is withdrawn from the show for any reason.

There are four wool divisions:

1. Suri: fleece with a luster and hand that drapes over the llama's body, usually forming a natural part along the spine. Fibers are grouped into a very distinctive and well-defined narrow lock structure.
2. Light: minimal body wool, short neck wool, with smooth legs
3. Medium: moderate to long body wool, minimal to moderate neck wool, smooth to moderate leg wool
4. Heavy: abundant body and neck wool with minimal to abundant leg wool

There are no wool divisions for the Non-Breeder llama halter classes.

Exhibitors must provide their own feed, hay, and bedding. Electricity for blowers and fans will be available. Water, of course, will also be available. 😊

We expect exhibitors to be prompt for each class. Once the class has entered the ring and the judge and gateman have agreed this is the class, late exhibitors may not enter. Exhibitors/animals will enter in numerical order. Bucking the order could result in being excused from the show. The Superintendent will excuse any exhibitor who shows poor sportsmanship, especially toward the judges, the ring steward, the gate keepers, or the runners.

This show is limited to 130 animals! Get your entries in!

If you don't have anything you want to show, then just come and have a good time!

In case of rain, we will try to wait it out. ☹️ Rarely has it rained all day. The show must go on! 😊

DIRECTIONS

The easiest way to find the Snyder Farm is from Illinois Route 36. Metcalf is east of Route 49 about 5 or 6 miles and west of Route 1 about 11 miles. You must turn north off Rte. 36 to go toward Metcalf. You will cross 2 sets of railroad tracks. Just keep going north about 3 miles to the first T-road left. This is 2525 Road. It is obscured by a home with a big evergreen right at the turn (on the left). There will be a llama sign there to help you find it! We're the only house on this short road. You can turn in the drive or go around the curve in the road and come in the back drive (past a hedge row & right next to another house) .
