After completion of this reformatting, and inclusion of all approved changes, the document will be suitable to post for online access. I will make the files available to whomever assumes the task of printing and distribution of hardcopies.

The January BOD Minutes approved a change away from the three-judge system for the Grand National. That precipitates changes to the Handbook in two parts that we have found. The following are the recommended changes to Parts F and T of the Handbook.

#### Part F - Grand National

Current Section 4.A. - Llama Halter judging must be done by a three-judge system.

Change to - The system to be used for judging the Grand National will be determined by the ALSA Board of Directors with the input of the Grand National Committee.

#### Part T - Halter Judging Systems

Current Section 4. Grand National - For the ALSA Grand National, the method combining the Judges placings from the three-judge system will be determined by the ALSA Board of Directors with the input of the Grand National Committee.

Change to - The system to be used for judging the Grand National will be determined by the ALSA Board of Directors with the input of the Grand National Committee.

Motion: The system to be used for judging the Grand National will be determined by the ALSA Board of Directors with the input of the Grand National Committee. Motion by Cathie. Seconded by Ron. Motion unanimously passed.

A second item...

There was a typo in Part O - Fleece in Section 1.B.1.d. that was approved by the BOD at the January meeting. There should not be a Section 1.B.1.d. The correct section is below.

B. 2 oz. Shorn Llama Fleece

The 2 oz. Llama Fleece class will follow the same rules as the Shorn Llama Fleece class except that entries in the 2 oz. Shorn Fleece class will be entered in gallon, plastic zip lock bags (A.4.b.vi) and slightly different judging criteria will be used than listed for Shorn Fleece in A.5. above.

- 1. Shorn Fleece Judging Criteria: 100 points possible. The following are the judging criteria used and recorded on the ALSA Score Card Llama 2 oz. Shorn Fleece
- a. Style
- i. Fineness: 15 pointsii. Hand: 10 points
- iii. Brightness/Luster (Suri): 15 points
- iv. Guard Hair: 10 points
- b. Character
- i. Over-all Uniformity: 15 points
- ii. Lock Formation/Crimp or No Crimp (Suri): 15 points
- c. Preparation:
- i. Tensile Strength & Condition: 10 pointsii. Cleanliness & Preparation: 10 points

Lynn and Staci will be sending the \$50 required judge's dues in the mail.

Due to the lack of Performance Judges Deb has suggested that the BOD certify Alpaca Judges for Performance as long their three performance apprenticeships are under a llama apprentice accepting Judge and the show performance classes have a minimum of 75 runs alpaca and/or llama.

- **5**. Updated Apprentice Evaluation form. See attached form. Please note the changes in the General Knowledge, and Oral Reasons section on the second page. We are trying to help the Apprentices and Supervising Judges think about components that make up a great Halter, Performance and Youth Judge. It is not just about the identification of traits and the ability to make quick comments through oral reasons, but show ring management, interaction with the exhibitors and staff, attention to detail in the performance ring and how to document the activities.
- **6.** I have been receiving phone calls from exhibitors and Judges about when the updated rules will take effect. They have been watching the Board minutes and see that some have been passed but I know that there is discussion that still may take place. Since we are still making revisions, may I suggest that the Board make a resolution that Handbook changes do not take effect until a formal announcement is made by the Board and the 2017 Rule Book stays in effect until that time **except for changes in rules relative to the Grand National Show and regional Shows that take effect, immediately, when voted upon by the Board of Directors**. This will bring clarity to the Judges and exhibitors and allow the Judge's Committee choose Judge candidates for the Grand National and the Grand National Committee to plan for the fall show

#### IV. Old Business:

#### A. Website problems.

Significant discussion resulted in the decision to leave the website located at its present server. A vote on revamping the website will be presented to the membership in March.

#### B. Discussion of Grand National for 2019.

The National Show will remain in Hutchinson, Kansas for 2019. A decision was made to start searching for a new 2020 location or locations.

C. Creation of a new Standing Rule that states the ALSA Board of Directors makes the final decision regarding Judges to be invited and employed for regional and national shows as well as to instruct clinics.

After discussion, it was determined such a rule was unnecessary.

#### **New Business:**

#### A. Discussion of new date for 2019 Handbook to be issued.

Inasmuch as Ruby has resigned from her position as Chair of Publications, Promotions, Marketing and Web Site, publication of the 2019 Handbook has been willingly assumed by the Handbook Committee. However, it likely will be late March before it is published.

### B. Discussion of rule change for performance classes.

Considerable comment has been heard regarding a rule change for the use of one lama by one youth, rather than allowing a lama to be used by more than one youth.

The background of this being brought up last month by the Performance Committee lie in the fact that complaints had been registered that many exhibitors at one show were using the same animal in the same class --- as many as five or more. This is not in accordance with good showmanship, sportsmanship, or animal welfare. With many things the current Board is discovering, something such as this is being referred to the Board rather than being properly attended to through common sense and consideration for animals.

The Board decided to send this decision back to the Performance Committee in order that it may reconsider the decision based on animal, exhibitor, superintendent and financial considerations.

The Board entered Executive Session at 8:50 p.m. upon a Motion made by Cathie, seconded by Ron, and unanimously approved in order to discuss frankly certain matters for which Executive Session is appropriate. The Board exited from Executive Session at 9:45 p.m. upon a Motion by Ron, seconded by Deb, and unanimously approved.

The next Board meeting will be March 20, 2019 at 7:00 p.m. CDT.

Motion to Adjourn at 9:52 p.m. CST Motion by Cathie. Seconded by Debbie. Motion unanimously passed.

The ALSA Board of Directors may convene in Executive Session to discuss personnel matters, any items on this agenda or to consult with Legal and/or Accounting Counsel.
