



YOUTH JUDGING CLASS - FORMS LIST

**A listing of forms and supplies needed for an
ALSA Youth Judging Class.**

- * **Although participants for Youth Judging Classes are encouraged to have clipboards and pencils, it is helpful to have extra pencils on hand for the youth who have forgotten.**
- * **Have exhibitor numbers 1, 2, 3, & 4 on hand for the handlers to wear in the Youth Judging Classes. These numbers must be used in order for the Youth Judging Placing Cards to work properly.**
- * **Specify whether you want the participants in the Youth Judging Class to be “dressed as Judges”.**
- * **Borrow or purchase (\$15) a Hormel Scale from the ALSA Office. This is needed to make final placings. If you have a computer with access to the internet, you can use the automatic Hormel Scale at <https://www.worldaccessnet.com/~normans/hormel.html>**
- * **Forms to have on hand:**
 1. **Youth Judging Program:**
Print off a copy of the ALSA Youth Judging Program. This has an explanation of what the class is about and how to conduct the class.
 2. **Performance Score Card:**
This is the score card that the youth will use to score the 4 handlers in the Obstacle Class section of the Youth Judging Class. There are two score cards per sheet. Each youth will need four (4) score cards.
 3. **Placing Card:**
This is the final Placing Card that the youth will use to mark their final placings in each of the classes they judge – showmanship, obstacle, and halter. There are three (3) score cards per sheet. Each youth will need one

full sheet cut into thirds printed off for their placings. Youth will figure their final placings for each of the three classes and then circle the correct order placings of the handlers, which have numbers 1 through 4. The 24 possible placings are noted on the Youth Judging Placing Card – the youth select the one that matches their placing for that class.

4. Junior Youth Judging Quiz:

The participants in the Junior division of the Youth Judging Class take a written quiz rather than give oral reasons for their placings in the Halter Class. There are a total of five (5) different quizzes (with correct answers) that may be obtained from the ALSA Office. Select one of the quizzes, and make one copy of the quiz for each of the Junior participants. Scores are then placed on the Youth Judging Summary Score Sheet.

5. Youth Judging Summary Score Sheet:

This is the form for the clerk to use for totaling all the scores, showmanship, obstacle, and halter, to determine the final placings for the Youth Judging Class. A total of three (3) of these forms will need to be printed off – one for each age division – Junior, Intermediate, and Senior.

6. Official Judge's Placing Card:

This form is used for the Official Judge to record their placings and “cuts” for the Halter, Obstacle, and Showmanship Class. The judge will need only one copy of this form. There are also instructions for using the Hormel Scoring System on this form.

7. Oral Reasons Score Card for Official Judge:

The Official Judge will use this card to give points to each Intermediate and Senior class participant as they give oral reasons for the Halter Class. There are three (3) score cards per sheet. You will need to have one score card for each Intermediate and Senior participating in the Youth Judging Class.
